1. Checks

All check donations must be made out to the International Documentary Association (or IDA) with the title of the project and film ID number clearly noted, preferably in the check's memo line. Please provide your mailing address, if your donation is over \$2,000. The mailing address cannot be a P.O Box. It's important to follow the instructions below very carefully.

6. Non-Cash/In-Kind Donations

You may donate a non-cash tangible good for direct use in the production. Some examples of this type of donation include equipment or office supplies.

Please note that we are unable to issue receipts for donations of time or professional services, as these are considered volunteer work and are non-deductible by law. We also cannot issue receipts for donated space, rent, or large ticket items like cars or boats.

IMPORTANT: The receipt we issue, in accordance with IRS regulations, will not specify a dollar amount for the deduction. We will simply describe the goods donated in detail, and you will have the responsibility of quantifying the donation and confirming it is deductible. If you have questions about a non-cash contribution's deductibility, please contact a tax professional.

7. Partially Deductible Donations

If you receive any good or service in exchange for your contribution to your project, the donation becomes *partially deductible*. For example, if you give IDA \$100 and receive an event ticket with a fair market value of \$40 in return, you have made a partially deductible contribution. In this example, the charitable contribution/deductible portion of the payment is \$60.

In a situation where the value of goods or services received is equal to or greater than the contribution, nothing is tax-deductible. In those cases, funds must go directly to the filmmaker rather than to IDA.

IMPORTANT: Our office must approve all partially deductible donor arrangements in advance!
